



Field Trips

Tigard-Tualatin School District supports learning in a variety of environments. Due to student safety and insurance concerns however, certain types of field trips are conditional or not allowed.

[TTSD Parent-Guardian Permission & Liability Release Form](#) is required for **all** District field trips & activities.

The following types of field trips are **conditional**:

- ✓ Amusement parks are allowed but need to be approved by the District.
- ✓ The **only** swimming or water activities allowed are trips to pools that meet the following criteria:
 - School administrator approves and supports the trip
 - Facility must be on the District preapproved list of pools
 - Preapproved pools: Tigard-Tualatin Aquatic District pools (Tualatin & Tigard), Aloha Swim Center, Beaverton Swim Center, Conestoga Recreation & Aquatic Center, Eastside Portland Community Center, Harman Swim Center, North Clackamas Aquatic Park, Oregon City Swimming Pool, Salem Salvation Army Kroc Center, Southwest Community Center, Sunset Swim Center, Tualatin Hills Aquatic Center
 - When completing [TTSD Parent-Guardian Permission & Liability Release Form](#), parent/guardian must identify their child as a "non-swimmer" or "swimmer" on the form. *Non-swimmers will need to stay in shallow water and wear life preservers at all times.

***Students may not go in to any rivers, lakes, ponds or oceans past their ankles.**

The following types of field trips are **PROHIBITED**:

- ⊗ All trampolines & trampoline parks.
- ⊗ Boat activities such as WyEast Expeditions, river rafting and jetboat excursions.
- ⊗ Swimming or any water activity – *see above for exceptions*.
- ⊗ Paintball, laser tag or other activities that involve shooting.
- ⊗ Open flames or activities involving fire.
- ⊗ iFLY, any indoor skydiving simulation or skydiving activity.
- ⊗ Ropes courses (high and low), rock walls and other such activities that involve height off the ground.
- ⊗ Bungee Jumping.
- ⊗ Horseback riding.
- ⊗ Mechanical bulls.

Reminder: * Field trips require Principal approval.

* Trips that are a) uncommon or unique to the normal activities program, b) involve one or more nights away from the district, or c) require fundraising are defined as an Extended Field Trip and require approval before planning or fundraising may begin.
